Non-winning entries will not carry forward into subsequent Entry Period drawings. The Administrator’s computer is the Sweepstakes official clock.

- C. Pool C:** California (Southern- see Appendix for eligible ZIP Codes), Colorado, Indiana, Louisiana, Ohio, Pennsylvania, and Texas.

Entry Limit: There is a limit of one (1) entry per person per day. If more than one (1) entry per day is received from the same person, telephone number and/or e-mail address the entries may, at the Sponsor's sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. Prizes (160 total; broken out below): Each prize is a Knob Creek Cast Iron Culinary kit that includes one (1) engraved cast iron with winner’s name, one (1) set of embossed cast iron handles, one (1) personalized oak trivet, one (1) etched cocktail mixing glass, and one (1) personalized swizzle bar spoon (each a “Prize”). ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
